



# AFTER-SCHOOL AGREEMENT

**3:00PM to 6:00PM**

I agree to pay the monthly after-school fee of \$160.00 for each child that I have enrolled. See Pay Period below for due dates and coverage.

The after school hours are noted above for all students.

I understand that failure to pay tuition on time more than two times will result in termination from the After School Program. There will be a \$25.00 late fee assessed for payments not received by due date.

I agree to pay a service charge of \$25.00 for a returned check. If a check is returned, for any reason, cash or money orders will be the only methods accepted by the School for the rest of the school year.

I understand that if my child is absent or on vacation, my tuition is still due. Under no circumstances will a partial payment be accepted. The tuition has been established in such way as for it to be pro-rated on a monthly basis throughout the school year. All holidays, including Christmas and Spring Break, and the month of May are included.

Failure to comply with the contract will result in my child no longer being enrolled in the after school program.

I also realize that if my child is picked up after 6:00PM, an additional fee will be charged to me as a late pick up fee as follows:

**A late fee of \$1.00 per child per minute after 6 pm**  
**A \$10.00/day charge if as need basis**
